ARTICLE 1. INTRODUCTION

1.1. Context

The TAO CTM Meeting, organised by Strategik & Numerik, whose head office is located at 86 avenue des Ternes, 75017 Paris, registered at the Chamber of Commerce under number 408 375 095, is intended to further the training of young doctors in oncology and supportive care.

1.2. TAO CTM Meeting

The TAO (Trans Atlantiques en Oncologie) Meeting emerged from the desire to share knowledge and experience between the American and European continents about toxicities of oncology treatments.

In line with the therapeutic developments in oncology over the last decade, the TAO Meeting has become the TAO CTM Meeting, for cancer toxicity management.

Currently established in the landscape of international congresses, this meeting brings together once a year, in Paris, renowned clinicians offering participants an educational and critical summary of studies and major recommendations on the tolerability of innovative treatments and the management of their toxicities.

1.3. Jean Klastersky Young Physician Award

Created in 2019, the Jean Klastersky Young Physician Award is an award dedicated to young physicians. This prize is sponsored by Prof. Jean Klastersky:

- initiator of supportive care at the global level;
- President and founding member of the Multinational Association for Supportive Care in Cancer (MASCC) from 1990 to 2000.

It recognises innovative approaches in the field of supportive care.

1.4. Goals

The aim of the Jean Klastersky Young Physician Award is to offer young physicians the opportunity to present, to an audience of local and international clinicians, an innovative protocol implemented in the field of supportive oncology care.

The Jean Klastersky Young Physician Award sessions that will take place at the TAO CTM meeting will also be an opportunity to discuss innovation in oncology in order to promote excellence in oncology care.

ARTICLE 2. TERMS OF PARTICIPATION

2.1. Conditions for application

In order to participate in the Jean Klustersky Young Physician Award, applicants must register for the TAO CTM meeting.

2.2. Candidate application dossier

The applicant must provide a presentation on one of the 3 options listed below:

- a clinical case showing innovative management;
- an organisation/an innovative care pathway;
- a proposal for a prospective or retrospective study (real-life or registry) about an innovative therapeutic or organisational approach relevant to the subject of cancer toxicity management.

The presentation must not exceed 9 slides (including the title slide) and must contain:

- one slide introducing the author;
- one slide introducing the issue.

The slide presentation must be written in English.

ARTICLE 3. PROCEEDINGS OF THE JEAN KLASTERSKY YOUNG PHYSICIAN AWARD

3.1. Calendar

The candidate selection procedure will be carried out according to the following provisional timetable:

3.2. Different steps

The competition takes place in 4 stages, from Thursday September 2 to Friday December 3, 2021, as follows:

I. Invitation for applications

The members of the TAO CTM Meeting Organising Committee (Advisory Board and Scientific Committee) are requested to forward this invitation to their colleagues.

II. Submission of application dossiers

Applications must be submitted via the website:

III. Announcement of the 6 dossiers selected by the jury

Based on the evaluation form, the jury will select 6 candidates from all the applications received (Annex 1).

The 6 candidates will be informed of this result by e-mail.

The names of the 6 candidates will also be published on the TAO CTM Meeting website.

Unsuccessful candidates will also be informed of the selection jury's decision.

IV. Presentation of the 6 finalists

Successful candidates will have until November 26, 2021 to finalise their presentation and resubmit it to the Organising Committee.

In order to maintain a level of homogeneity of formatting and the amount of information presented, each successful candidate will be sent a slide template with the graphic identity of the TAO CTM Meeting, including a mandatory presentation structure.

The final version of the presentation must not exceed 9 slides (including the title slide).

Each candidate will be allocated a 20-minute session to deliver their presentation, structured as follows:

- 15-minute presentation;
- 5-minute Q&A session.

The oral presentation must be given in English.

ARTICLE 4. COMPOSITION AND MISSION OF THE JURY

4.1. Composition

The selection jury will be composed of:

- Dr Richard Berman (United Kingdom),
- Dr Paolo Bossi (Italy),
- Prof. Richard Gralla (USA),
- Prof. Karin Jordan (Germany),
- Prof. Jean Klastersky (Belgium),
- Prof. Ivan Krakowski (France).

Dr Florian Scotté, founder and coordinator of the TAO CTM Meeting, will also be involved in the selection process of the 6 finalists for the Jean Klastersky Young Physician Award.

4.2. Commitment to independence and confidentiality

The members of the selection jury for the Jean Klastersky Young Physician Award undertake to:

- make decisions in total independence and according to the evaluation criteria listed in this rules document;
- ensure documents are treated in the strictest confidentiality, and only for the purposes of awarding the Jean Klastersky Young Physician Award.

4.3. Declaration of conflicts of interest

To be part of the selection jury, members must first make a formal commitment to recuse themselves if the application dossier involves:

- a candidate who works in the team of the jury member concerned;
- a candidate who works in a team in direct contact with the jury member concerned;
- a candidate who works in, with, or for the healthcare institution where the jury member concerned works.

4.4. Method of allocation

The jury will consult in November 2021 to deliberate and to select the 6 best candidates on the basis of the predefined evaluation form in Annex 1 of these rules.

During the TAO CTM Meeting, which will take place on December 2nd and 3rd, 2021, participants and all members of the TAO CTM Meeting Organising Committee will vote to nominate their preferred project. They will have until Friday December 3, 2021 to choose the winner of the Jean Klastersky Young Physician Award.

The project with the most votes will be awarded a prize.

4.5. Announcement of results

The result of the Jean Klastersky Young Physician Award will be announced by Prof. Jean Klastersky at the TAO CTM Meeting on Friday December 3, 2021.

ARTICLE 5. PROJECT ELIGIBILITY AND EVALUATION CRITERIA

5.1. Eligibility criteria

This invitation for applications is open to any young doctor (intern, young clinic manager, young hospital practitioner), working in a service involved in the care of cancer patients.

Each candidate may submit only one project.

Any dossier that is incomplete or does not comply with the rules described in Article 2 will not be submitted to the selection jury.

5.2. Evaluation criteria

Applications satisfying the eligibility criteria will be assessed on the basis of the following criteria:

- appropriateness to the subject of cancer toxicity management;
- relevance;
- originality;
- medical and scientific rigour of the approach;
- applicability to clinical practice;
- quality of the written presentation.

ARTICLE 6. JEAN KLASTERSKY YOUNG PHYSICIAN AWARD

6.1. Grant

The Jean Klastersky Young Physician Award will award to 1 finalist the following grants:

- financial allowance of € 2,000;
- registration for the next meeting of the MASCC (Multinational Association of Supportive Care in Cancer), which will be held in 2022 in Toronto (Canada);
- membership of the MASCC.

In return for this registration to the MASCC, the winner is requested to provide the Organising Committee of the TAO CTM Meeting with a report of the major news from this congress (minimum one to two pages), which will be published on the TAO CTM Meeting website.

6.2. Conditions for awarding the grant

The awarding of the prize is conditional on the physical presence of the selected candidate at the presentation session, as well as at the award ceremony, which will take place during the TAO-CTM meeting.

ARTICLE 7. INFORMATION TECHNOLOGY AND DATA PROTECTION

Participation in the Jean Klastersky Young Physician Award requires the communication of the candidate's personal data (see Article 2).

In accordance with law n° 78-17 of January 6, 1978, each participant has, at any time, the right to:

- refuse the collection and processing of their personal data by the beneficiary;
- refuse the sharing of their personal data with third parties;
- refuse access to the totality of their personal data processed by the beneficiary;
- rectify, update and delete personal data processed by the beneficiary.

To exercise their rights under law n° 78-17 of January 6, 1978, the candidate must send a registered letter with acknowledgment of receipt clearly mentioning his or her name and the subject of the request to Strategik & Numerik, 86 avenue des Ternes, 75017 Paris.

Regarding the possible installation of cookies (or connection witnesses) on the participant's computer when accessing the beneficiary's website, the participant is invited to consult the rules and selection criteria available on the platform and that he or she must accept prior to registration for the Jean Klastersky Young Physician Award.

ARTICLE 8. RESPONSIBILITY
